

Cookie and Privacy Policy

The General Data Protection Regulation (GDPR) - which came into force on May 25th, 2018 - aims to protect the fundamental right to privacy and the protection of the personal data of European Union (EU) citizens. - ❖ a reference to a person includes firms, companies, government entities, trusts and partnerships;
- ❖ "including" is understood to mean "including without limitation";
- ❖ reference to any statutory provision includes any modification or amendment of it;
- ❖ the headings and sub-headings do not form part of this Cookie and privacy policy.

Scope of this privacy policy

- I. This privacy policy applies to the actions of Live Your Life Sàrl-S and Users with respect to the Website www.gyorfi.lu and to the Services of Live Your Life Sàrl-S, ie. to any contract or electronic payments between the parties. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

We may collect the following Data, which includes personal Data, from you:

- ❖ nationality

- ❖ IP address (automatically collected);
- ❖ web browser type and version (automatically collected);
- ❖ operating system (automatically collected);
- ❖ a list of URLs starting with a referring site, your activity on this Website, and the site you exit to (automatically collected);

in each case, in accordance with this Cookie and privacy policy.

How we collect Data

We collect Data in the following ways:

- ❖ data is given to us by you
- ❖ data is received from other sources; and
- ❖ data collected automatically

Data that is given to us by you

Live Your Life Sàrl-S will collect your Data in a number of ways, for example:

- ❖ when you contact us through the Website, by telephone, post, e-mail or through any other means;
- ❖ when you register with us and set up an account to receive our Services;

- ❖ when you complete surveys that we use for research purposes (although you are not obliged to respond to them);
 - ❖ when you make payments to us, through this Website or otherwise;
 - ❖ when you elect to receive marketing communications from us;
 - ❖ when you use our Services;
 - ❖ when you participate in our events, promotions;
- in each case, in accordance with this Cookie and privacy policy.

Data that is received from publicly available third parties sources

We may receive Data about you from the following publicly available third party sources:

Data that is collected automatically

To the extent that you access the Website, we may collect your Data automatically, for example:

- ❖ we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
- ❖ we will collect your Data automatically via Cookies, in line with the Cookie settings on your browser. For more information about Cookies, and how we use them on the Website, see the section below, headed "Cookies".

How we use your Data

Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website and Services.  - ❖ relevant authorities to enforce any contract we may have with you
- in each case, in accordance with this Cookie and privacy policy.

Keeping Data secure

We will use technical and organizational measures to safeguard your Data, for example:

- a. access to your account is controlled by a password and a user name that is unique to you.
- b. we store your Data on secure servers.

Your rights

You have the following rights in relation to your Data:

- ❖ **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
- ❖ **Right to correct** - the right to have your Data rectified if it is inaccurate or incomplete.
- ❖ **Right to erase** - the right to request that we delete or remove your Data from our systems.
- ❖ **Right to restrict our use of your Data** - the right to "block" us from using your Data or limit the way in which we can use it.
- ❖ **Right to data portability** - the right to request that we move, copy or transfer your Data.
- ❖ **Right to object** - the right to object to our use of your Data including where we use it for our legitimate interests.
